#### **2025 USEF MEMBERSHIP/SHOW PASS RULES for Non-Members**

*Non-member participants in the role of riders, drivers, handlers, vaulters, lungers, owners, lessees, and agents must pay a Show Pass fee. Competitions cannot accept payment for a Show Pass from exhibitors. Show Pass purchases can only be made online on the USEF website by exhibitors. Non-member participants in the above roles are limited to obtaining **no more than one (1) Show Pass per competition year** (December 1, 2024-November 30, 2025). The online Show Pass form is available on the USEF website at <https://www.usef.org/show-pass> The Show Pass form cannot be completed until a competition start date is within the next 14 days or if the show is currently in progress. Make sure to check current rules on website. Show secretary is notified of show passes by USEF.*

*To be eligible to participate at Federation Licensed Competitions, all persons acting as coaches or trainers, and legal guardians signing entry blanks as coaches or trainers on behalf of their minors must be Senior Active Members in good standing.*

Please note: USEF/USDF membership and USDF horse ID requirements are not required for Intro Level/Opportunity classes. Horses must have a USEF HID (available on USEF.org)

#### **USEF WAIVER FORMS and USEF Entry Agreements REQUIRED**

**EVERYONE** (riders, owners/agents, trainers, coaches, officials, staff, volunteers and any others) **MUST** sign a USEF State Specific (MD) Waiver Form (on last page of Prize List). No one may enter the grounds without a signed waiver form.

#### **SAFE SPORT**

*All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. #### **CLASS LEVELS:**

USDF Intro through FEI Grand Prix, Freestyles, Junior, YR, Pony plus USEF Opportunity classes, Dressage Seat Equitation, Para-Equestrian, FEI Young Horse, Brentina Cup and USEF National Championships Qualifier Classes

All classes listed on pages 3-5 are USEF/USDF recognized. To enter these classes rider/owner/trainer must all be members of USEF or buy a show-pass online at USEF.org no earlier than 14 days prior to the show (non-member) fee for each. Rider must be USDF Participating or Group member or pay a non-member fee. All horses must have at least a USDF and USEF HID # to enter. Owners of horses competing in this competition (non-qualifying rides), may have a USDF Participating, Group, or Business Membership or pay the USDF non-member fee. In regards to the (GAIG Q) Great American Insurance Group/USDF Regional Championship qualifying classes, horses must be USDF lifetime registered and USEF annual or lifetime recorded, riders are required to have an active USEF membership & USDF Participating Memberships. If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF. Riders/owners/trainers/coaches must all be current with the USEF Safe Sport training. All persons signing as Trainer must have USEF Senior membership. This includes parents signing as Trainer. The Trainer is the person legally responsible for the horse on the showgrounds. A minor cannot sign as the Trainer.

## SHOW DEFINITIONS/ELIGIBILITY:

**CBLM** – Qualifying class for 2025 CBLMs. Riders must be members of a participating GMO organization at the time of the show to be eligible.

**GAIG/USDF** – Qualifying class for the 2025 GAIG/USDF Championships. Rider must *declare qualifying ride on entry form*. Entry fee **plus additional \$20** required. **Must be paid prior to the start of the class**

**Open** – Open to all horses and riders. Show management may split into AA and JY based on class size.

**AA** – Open to Adult Amateurs only; competitors must compete as adults from the beginning of the calendar year in which they reach the age of 22 and must hold a current USEF Amateur card.

**Junior/Young Rider (JY)** – Open to Juniors and Young Riders only. Any rider is eligible until the end of the calendar year in which they reach the age of 21. Only riders ages 14-18 may ride FEI JR tests. Only riders ages 16-21 may ride FEI YR tests.

**FEI Pony/Children**--Only riders ages 12-16 may ride FEI Pony tests. Only riders ages 12-14 may ride FEI Childrens' tests.

**USEF Q** – Qualifying class for 2025 USEF National Championships

**NAYC/USEF Q**- Qualifying class for 2025 North American Youth Championships and USEF National Junior and Young Rider and Developing Horse Championships.

**TOC** – Test of Choice (*specify test on entry form*). May be GAIG/USDF Qualifier if proper test ridden & fees paid.

**Materiale Classes:** Entries must be at least 36 months old to enter. To be judged under saddle at the walk/trot/canter in both directions according to the criteria on the “USDF Materiale Class” score sheet.

Management reserves the right to combine classes of the same sex by age.

**AAEP:** USDF Regional Adult Amateur Equitation Program

**Pony Only:** Class limited to ponies with current USEF/FEI Dressage pony measurement card. Will receive NDPC ribbons.

\*\*\*\***NDPC TOC:** Limited to members of NDPC (Sm. Horse/Pony measurement and membership with NDPC required to enter) Go to <https://dressageponycup.com/> for more information.

## PRIZE LIST DIRECTIVES

**LEVELS:** Levels listed above. Classes will be split if entries warrant for Open, Adult Amateur and Junior/Young Rider divisions. All tests current editions. Make sure to verify you are riding the correct test. If entering a Test of Choice, specify test on entry form.

**OPPORTUNITY CLASSES:** Held in accordance with USEF GR821. Scores from these classes will not be included for USEF high point or year-end awards. Horses entered only in these classes are exempt from USEF/USDF fees, including the Equine Drugs and Medication fee, but they are still subject to and must comply with the Drugs and Medication rules and may be selected for drug testing. Horses entered only in these classes are not required to have a USEF/USDF number but are to list the numbers if the horse has been registered with either federation. Riders who enter only Opportunity Classes are exempt from USEF/USDF membership requirements and are not required to pay a non-member fee, but are required to list membership numbers if the participant is a member. Riders and horses may also enter Introductory Classes with the same exemptions. Cross entry to other classes is allowed, but then all applicable fees and membership requirements apply.

**FREESTYLES:** Freestyle class entries require copies of qualifying tests at that level (or any higher-level test) verifying eligibility from a USEF Licensed Open Dressage Show to be submitted at time of entry. Riders should submit music on good quality CDs to the announcer's booth the morning of their rides, or contact the show secretary if sending digital music files. Music should be labeled with horse/rider names, instructions, and class number. Times for sound checks will be announced and posted at the show. With the exceptions noted below, in order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% for Training through Fourth levels in the highest test of the declared freestyle level or any test of a higher level. For the FEI levels, a horse/rider combination must have received a minimum score of 60% at the declared freestyle level or any test at a higher level. Scores must be received at a Federation /USDF Licensed Dressage Competition or FEI recognized Dressage Competition or “open” Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. The 63% minimum qualifying score applies to all Training through Fourth level Freestyles, even if an FEI test is being ridden as a qualifier. For example, a horse/rider combination competing in

PSG or the FEI Young Rider test must obtain a score of 63% or higher in order to ride a Fourth Level Freestyle and a horse/rider combination riding the FEI Pony Rider test must obtain a minimum score of 63% to enter a Second Level Freestyle. To enter an FEI Para Dressage Freestyle class, a horse/rider combination must have received a minimum score of 60% in any FEI Para Dressage test (Para Novice Test, Para Intermediate Test or Para Grand Prix Test) at the rider's classified Grade. This score may be earned at a USEF/USDF licensed Dressage Competition or FEI recognized Dressage Competition or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A copy of the USDF score verification or a photocopy of the test verifying eligibility, must be submitted with the entry for a freestyle class. All FEI Pony Rider Tests are equivalent to Second Level; all FEI Junior Tests are equivalent to Third Level; all FEI Young Rider Tests are equivalent to PSG; and the USEF Brentina Cup (Young Adult) Test and FEI Young Rider Grand Prix 16-25 Tests are equivalent to Intermediate II. For purposes of freestyle qualification, all are considered equivalent to the highest test of that level and may be used to enter a freestyle at that level or a level below, as long as the appropriate score is earned. Young Horse and FEI Children Tests cannot be used for freestyle qualification at any level.

**PRIZE GIVING CEREMONY: There will be no prize giving ceremonies for any class, and no mandatory participation required.**

**AWARDS: Ribbons** for First through Sixth place. Prize for each first place in classes of 3 or more.

**Dressage High Score** awards each day at Intro, Training-Fourth Levels, FEI, MFS (ex. Equitation, Matiere, Opportunity, & YH tests).

**TIP Awards:** The Jockey Club Thoroughbred Incentive Program (T.I.P.) is offering a high score ribbon each day for Thoroughbreds enrolled in the T.I.P. Eligible horses must provide T.I.P. numbers to the event secretary with entry. For more information, visit [www.tjctip.com](http://www.tjctip.com). High Score ribbons will be awarded for Training, First, Second, Third/Fourth, and FEI Levels. All classes count except Equitation, Matiere, Freestyle, Intro, YH tests, and Opportunity.

#### **NEW THIS YEAR!**

**High Score ribbon for horses registered with the International Georgian Grande Horse Registry** (<https://georgiangrande.com/>). The IGGHR is also offering a \$500 year end award for registered IGGHR horses in each region.

**High Score Ribbon sponsored by the International Andalusian and Lusitano Horse Association. Will be awarded to the IALHA registered horse (Andalusian, Lusitano, S/P or half-bred)** that earns the highest score during the show. To be eligible, registered horses must be owned or shown by an IALHA member. Provide IALHA registration and membership proof with entry. #### **ALSO NEW THIS YEAR!**

Eden Ridlon/Watermark+ **Year End Memorial Award: To celebrate the Arabian spirit that Watermark+ (Marco) embodied**, \$100 to be awarded to the highest scoring Arabian/Half Arabian at 3<sup>rd</sup> Level in ANY of the 2025 Loch Moy licensed Dressage shows (April, May/June, and August). AHA papers required with entry to be eligible for this award. This award will be determined after the Loch Moy Summer Dressage Festival IV and winner will be notified either at the show or via email.

#### **We are now a NDPC Partner Show!!**

- Pony Test of Choice classes are height restricted. Non NDPC member ponies are allowed to compete in this class. All ponies that are not members are eligible for NDPC prizes. We are also offering a NDPC Member Test of Choice. A current NDPC membership card or receipt from a current membership purchase must be presented with the entry to be eligible to compete in this class.

**On-line entries** can be accessed through Horse Show Office ([www.https://horseshowoffice.com/#/events](http://www.https://horseshowoffice.com/#/events)) or through StriderPro ([STRIDER\(striderpro.com\)](http://STRIDER(striderpro.com))). Utilize this way to pay by **Credit Card**. Individuals utilizing the online entry system for this competition do so with the agreement that they have read the official prize list and agree to follow all the class specifications, requirements and conditions in the official prize list. If online is used, please be aware if the show has to be canceled, there may be up to a 3-week delay in processing your refund.

Valid digital signatures (A valid digital signature comprises three things; a hashing algorithm, public-key encryption, and a trusted digital certificate issuer) electronic signatures are accepted. Simply typing the name on the signature line is not sufficient.

(Exception: in the case of Interruption of Procedure, see GR 832) Entry scratches received **BEFORE** midnight of the closing date will be refunded less the full office fee.

**Non-Compete Horses:** Owners of non-competing horses must contact the Show Secretary at least two weeks before the show. A non-compete horse form will be emailed to the owner. Owners will be asked to mail a non-compete entry form, a copy of the negative Coggins and vaccine records showing Flu/Rhino within 6 months, and pay \$65 (\$30 grounds fee, and \$35 office fee). Non-competing horses do not pay the USEF D&M horse fee.

#### **ENTRY REQUIREMENTS:**

- 2025 entry form and ink or digitally signed USEF Entry Agreements (from riders, owner, trainers and, if applicable, coach) and emergency contact
- Ink or digitally signed USEF Waivers (from people included above and any others associated with the horse, e.g. groom or others)
- Proof of current USEF/USDF memberships and horse registrations/IDs and memberships for all above (available at eqverification.org) If emailing, PDF or scanned documents are requested.
- Proof of rhino/flu vaccines within 6 months of April 20, 2025 If emailing, PDF or scanned documents are requested.
- Current negative Coggins valid through the last day of the show. **Date used is date blood was drawn. If emailing, PDF or scanned documents are requested.**
- Fees, paid in full
- Any qualifying tests required for entry (e.g. for Freestyles)
- USEF membership and Safe Sport Training for adults with USEF membership, including parents signing as trainers. Refer to Page 2 of this prize list for updated information on Safe Sport and Show Pass policies/procedures.

Please indicate your status (OPEN, AA, or JR/YR) on entry blank. Note if you wish to qualify for GAIG/USDF 2025 Regional Championships. If riding in a Test of Choice class, include the test name.

Entries for GAIG/USDF Qualifying must include proof of full USEF Annual or Lifetime recording and USDF Lifetime registration for horse. Rider **and** owner must be current USEF/USDF Participating/Business members.

**Incomplete entries subject to \$20 incomplete entry fee (missing Coggins, missing vaccinations, missing proof of USEF/USDF registrations/memberships, USEF waivers, emergency contact, and/or signatures on entries will constitute incomplete entries). All documents must be received by 5 PM Tuesday, April 15 to avoid the fee.**

#### **HEALTH REQUIREMENTS (GR870 – Competitor Biosecurity)**

A Negative Coggins (EIA) within 12 months. When traveling from OUT OF STATE a Health Certificate is required within 30 days of competition. The date the blood was DRAWN is the date used.

#### **GR844 Equine Vaccination Rule**

1. At Federation licensed competitions horses, more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian.
2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration.
3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration.
4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested.
5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee. Current vaccination against WNV, EEE, WEE, Tetanus and Rabies is strongly recommended.



**RIDE TIMES AND UPDATES:**

Tentative ride/class times and stabling will be available online at [www.lochmoyfarm.com](http://www.lochmoyfarm.com) and on HorseShowOffice.com by the Wednesday night prior to the show and emailed to competitors. PLEASE check the website frequently for any show changes. Official Ride Times will be posted at the showgrounds by noon the previous day.

**STABLING:** Priority given to full weekend stabling. **Please choose Package A stabling (\$150.00) for Weekend stall on Saturday entry only.** 118 permanent 10 x12 stalls on site with stall doors. \$75.00 per night. **NO SCREW EYES ALLOWED!** Include SEPARATE \$50 check muck deposit per horse stall. **If Stabling and Muck fees are combined into one check, the Muck fee will not be refunded.** To arrange early arrival/late departure, call 301-514-0111. Bedding available for purchase if preordered on stabling form. Shavings \$12/bag Limited # of electric hook-ups around stabling for campers: \$50/night.

**Stalls must be stripped and swept clean prior to departure.** A separate stall cleaning deposit check for \$50 for each horse stall must be left with the secretary. It will be returned or shredded when stall(s) are found to be clean. Bedding is available by pre-order. Please see the barn manager to have her check your stall to make sure it is cleaned according to Loch Moy Farm requirements. You will be given a slip of paper to take to the show office upon departure to receive the return of your Muck Fee deposit.

**GENERAL:**

**FULL SHOW:** Entries may be limited if numbers exceed capacity of the facility. The show may fill prior to the closing date. Entries received after the show is full will be placed on a waiting list.

**LATE ENTRIES:** Late entries (received by the show secretary after midnight of the closing date) will be accepted on a space available basis. Must include the \$50 late fee.

**SHOW AND ENTRY CHANGES:** Show management reserves the right to refuse entries, make changes, deletions, or corrections as deemed necessary.

**COGGINS:** Negative Coggins valid **through** the show date is required to enter the show grounds for all horses. **Date used is the date the blood was drawn.**

**CORRESPONDENCE:**

All entries correspondence will be via snail mail or email. No telephone or FAX correspondence.

**DO NOT** send any entry documentation via registered, certified mail, or signature required.

**CHECKS:** If additional fees must be collected, make checks payable to **Loch Moy Farm.**

**USEF rules** are in force from the moment show management allows access to the showgrounds. This includes conduct, COVID compliance, correct saddlery and equipment, and attire.

“**No Shows**” that have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled. Competitors enter with this understanding and agreement.

**All horses must be wearing numbers at all times, including when outside of stalls or by trailers.**

Each barn has one sharps container per 50 horses available.

**VET/FARRIER:** on grounds or on call. Contact information will be posted in the center aisle of stabling and at show office.

**MANAGEMENT:** Show management reserves the right to refuse, accept conditionally, and/or cancel award of prizes without claims for damages, and to change the order of classes or cancel or combine classes at its discretion if entries deem necessary. Management also reserves the right to substitute judges if necessary.

**RETURNED CHECKS/DECLINED CREDIT CARD OR ELECTRONIC PAYMENTS** will incur a \$50 fee. If not rectified within 10 days, the matter will be turned over to USEF for disciplinary action.

**PARKING:** Parking is at the top of the hill at the end of the driveway to the left or right. Parking staff will direct trailers as they enter the show grounds. **PLEASE** be kind and cooperate with the parking staff in a cordial and polite manner. Parking for **STABLING** will be as follows: Unload your horse(s) at the barn upon arrival. Then park your trailer on the grass just below the small red barn, unless you have purchased one of our limited hookup spots. Trucks will be allowed to park at the barn once the trailer is detached. **NO TRAILERS WILL BE ALLOWED TO PARK AROUND THE BARN** without a camper hookup pass.

**MOTORIZED VEHICLE STATEMENT (GR 1301.7 and 1301.8):**

**GR1301.7:** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**GR1301.8.** The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**USEF MEMBERSHIP STATEMENT (GR901.9)** Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; and 7) assistant handlers in Dressage Sport Horse Breeding classes.

**COVID-19**

*Please be aware that there may be COVID-19 Rules and Guidelines that Loch Moy will implement based on the USEF Action Plan and local requirements to keep competitors and staff/volunteers as safe as possible. Competitors will be updated through group and social media communication if any actions that may need to be implemented. We appreciate your cooperation and patience. **SAFE SPORT: GR: 901.29: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. **CONCESSIONS:** Food concession breakfast and lunch. Limited menu.

**DOGS must be leashed at all times.** Fines will be assessed for unleashed dogs.

**PONY MEASUREMENT:** If ponies are entered and are in need of a measurement card, **an appointment for measuring MUST be made with show management at least ten days prior to the show.** A fee of up to \$100 will be charged by the veterinarian. A Pony Only class is offered each day, and ponies MUST have a current pony measurement card to compete in that class.

**FOOTING:**

**Warm-up Arena:** One 220' x 550' outdoor arena with all weather footing.

**Lungeing Area:** One 200' x 220' outdoor arena with all weather footing.

**Competition Arenas:** Three or four 20m x 60m outdoor arenas with all weather footing.

ALL riding, lungeing and exercise is permitted only in designated rings.

**FLY HOODS: DR121.7:** Fly hoods (ear covers) are permitted for all classes in order to protect horses from insects. The fly hoods should be discreet in color and design and should not cover the horse's eyes. After completion of the test, the rider or his representative is responsible for removing the fly hood to present to the designated ring steward for inspection to ensure that nothing prohibited has been added (for example, ear plugs).

**RIDER ATTIRE:** Refer to USEF Rulebook DR 120 for the most recent attire rules for dressage.

**HEADGEAR RULE:**

**DR120.1.1 Protective Headgear.** Protective headgear in compliance with the accepted testing standards published on the Federation's website. Protective headgear must carry the applicable quality testing tag and/or label. See GR801. From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, mounted participants in exhibition classes, and those competing in all classes and tests, including Para Dressage tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. The harness must be secured and properly fitted. Any rider violating this rule at any time must immediately be prohibited from further riding until the headgear is properly in place. Protective headgear may be the same as or a coordinating color with the coat, and may include contrast coloring, accent, and crystal decoration. See DR136 for dress code rules for exhibitions.

## **USEF Show Rules and Regulations:**

- **EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.**
- **All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final.**
- **Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise.**
- **The management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit entries and cancel award prizes without claims for damages; to cancel or combine unfilled classes, or to reschedule classes after due notice to exhibitors; to change rings or rotate judges.**
- **Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee and other fees.**
- **Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation.**
- **In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste.**
- **No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform.**
- **It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitable presented to appear before an audience.**

From Frederick, MD *Approximate distance: 10 miles:* Take Route 15 South and follow as it becomes Route 270 South. From Rt. 270 South, take Exit 31B for Buckeystown and Route 85 South. Continue straight off the exit ramp on Rt. 85 South for approximately 5-6 miles to Lily Pons Road on the left. Turn left onto Lily Pons Rd. and continue to the stop sign. Turn right onto Park Mills Rd. and continue straight for approximately 1.8 miles to the entrance on the right.

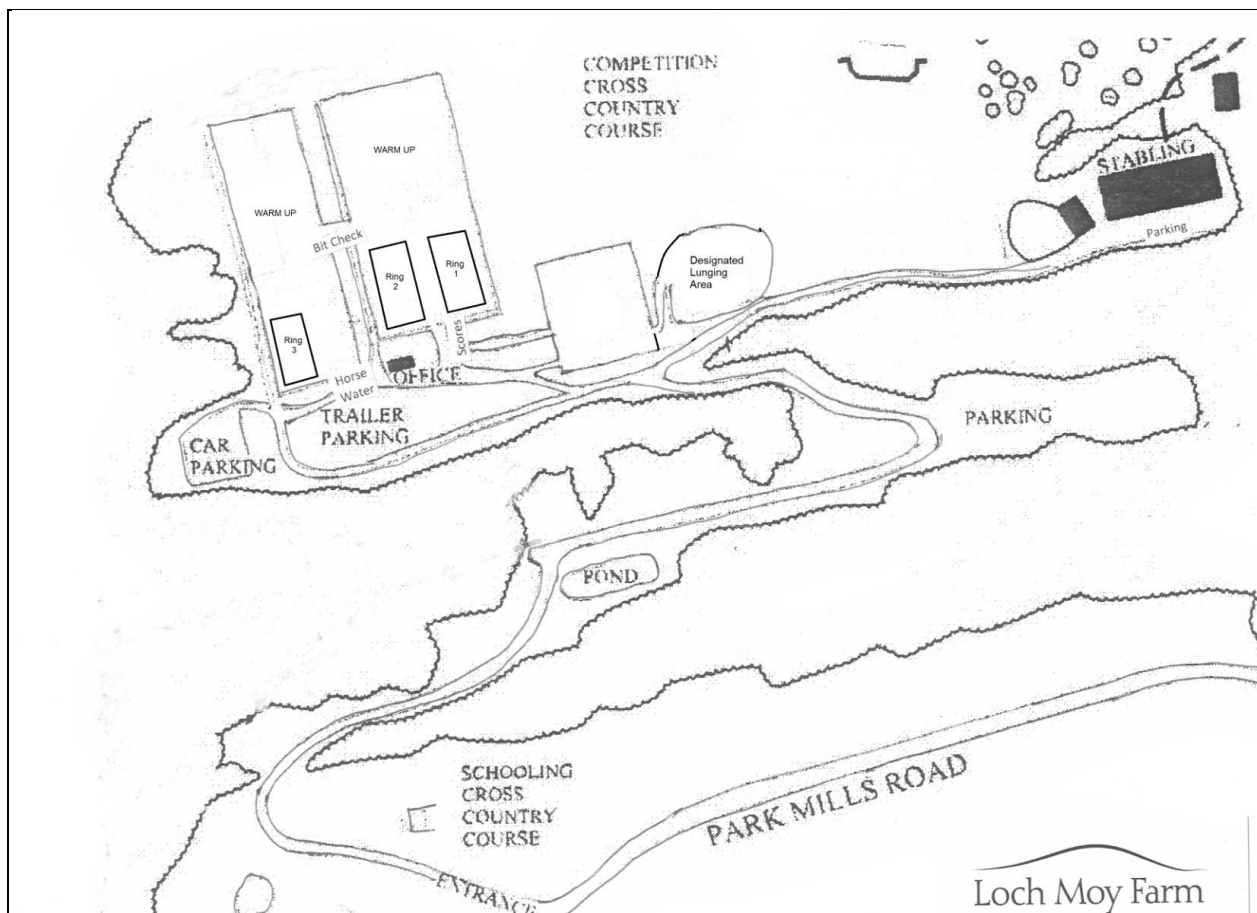
From Charles Town, WV *Approximate distance: 30 miles:* Take Route 340 West towards Frederick, Maryland. Follow signs to Route 270 South for Washington, D.C. Continue on Rt. 270 South to Exit 31B for Buckeystown, Route 85 South. Continue straight on Rt. 85 South for approximately 5-6 miles to Lily Pons Road on the left. Turn left onto Lily Pons Rd. and continue to the stop sign. Turn right onto Park Mills Rd. and continue straight for approximately 1.8 miles to the entrance on the right.

### Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8<sup>th</sup> Place and gift certificates awarded to top four riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

#### Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.
- or*
- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

#### Membership Requirements

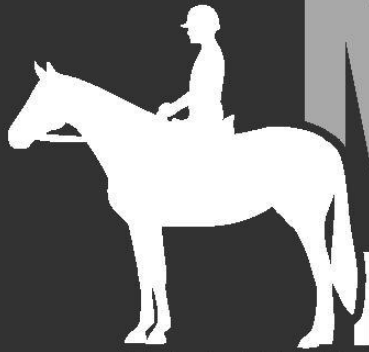
- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

**Membership Requirements for USEF-licensed/USDF-recognized Competitions:** Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

**Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

**Memberships Defined**

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

**How to Join USDF**

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: [www.usdf.org](http://www.usdf.org). You can submit the application online or download the form.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.



## 2025 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at [www.usdf.org](http://www.usdf.org). Please refer to the 2025 USDF Member Guide for the comprehensive list of rules and requirements for this program.

### Membership/Registration Requirements for Qualifying and Championships

*All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.*

#### Rider:

- Must have a USDF Participating\* Membership (PM).
- Must have a USEF membership (Active or Life).

#### Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).  
A horse is not required to have breed registry papers.
- Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

#### Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual or Life Recorded Farm/Business). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

\* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

**Minimum Qualifying Scores:** One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider.

## USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

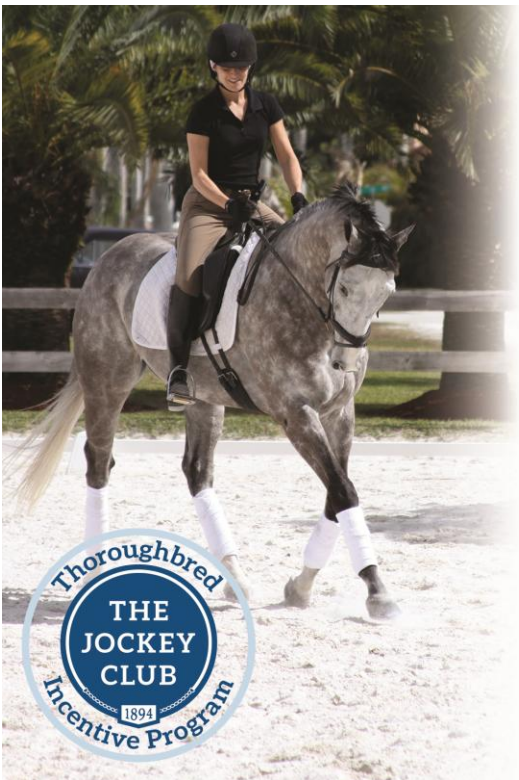
The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and Loch Moy Dressage ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

**A. RULES AND REGULATIONS:** I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at [www.usef.org](http://www.usef.org), as amended from time to time.

**B. ACKNOWLEDGMENT OF RISK:** I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

### EQUINE ACTIVITY LIABILITY ACT WARNING:

(the "Federation") and the local rules of Loch Moy Dressage (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

If not currently a USEF Active Competing member or Subscriber, I acknowledge that I will be enrolled for no cost as a USEF Fan and my USEF Fan Account will continue to annually automatically renew in USEF's sole discretion. Additionally, I acknowledge that the benefits of a USEF Fan are subject to change without notice. USEF may in its sole discretion, at any time, terminate my USEF Fan status.
